#### I. INTRODUCTION

#### A. BACKGROUND

Sustainable Development Goals (SDGs) 4.2 and Government Regulation Number 59 year 2017 on the Sustainable Development Plan states that by 2030 the Indonesia government guarantees all children have access to quality early childhood development, care, and early year education.

In order to support the government goals, the Southeast Asian Ministers of Education Organization Regional Center for Early Childhood Care Education and Parenting (SEAMEO CECCEP) was established, which is part of the organization of the Southeast Asian ministers of education. The establishment of this center is to increase the development of early childhood education (PAUD) and Parenting and manifest the commitment of Southeast Asian countries in increasing the competitiveness of the ASEAN community.

One of the SEAMEO CECCEP programs is conducting quality research for lecturers, researchers, academics to increasing research productivity which is oriented to the national and international scientific publications. All programs aimed to produce scientific works in various products such as academic articles, scientific journals, books, and other forms which could disseminate at the national or international level. Understanding the need of researchers for conducting research, especially among lecturers, researchers, academics, or educational practitioners, SEAMEO CECCEP developed a research grant program applied on a limited basis for 14 selected research proposals from researchers, academics, and educational practitioner.

2021 is the third year of the SEAMEO CECCEP Research Grant program. The four major themes of SEAMEO CECCEP research in 2021 are compiled based on the themes of the development of the SEAMEO CECCEP Program, namely 1) Quality Learning Environment and 2) Policies and Programs for 21st-century learning, while for the field of Parenting are 3) Inclusive, Cultural Relevant, and Sensitive Parenting Education Programs, and 4) 21st Century Parenting.

The quality learning environment's theme aims to understand the relationship between the environment, the school, and child welfare. The previous study shows that the right ECE environment will provide a strong foundation for future education and child development. Understanding the quality of the learning environment is necessary to comprehensively look at a complex and dynamic system, including the quality of teachers, facilities and infrastructure, teacher-child and teacher relationships, children's experiences with peers, and children's relationship with the home environment.

Based on an ecological perspective, several factors affect children's development. The factor creates a circumstance between children as individuals, families, the environment, and broader social discourses that can affect children's welfare. Education Policy is one of the factors that contribute to the ECE services. As the policies and programs contribute to educational practices, the theme of Policies and Programs for 21st-century education was raised in the research grant.

Meanwhile, the parenting theme will explore parents' knowledge and practices from diverse backgrounds such as certain indigenous tribes, low socio-economic-status, minority groups, or families with special needs children. By raising this research theme, the research result is expected

to be a positive input for parents, teachers, schools, and the government to make parenting programs sensitive and culturally responsive. Besides, other themes will cover topics such as negotiating the use of technology with parenting or exploring parenting best practices in the family with various backgrounds.

The 2021 Research Grants Program aims 14 research proposals for researchers, academics, and educational practitioners in the ECE and Parenting. The 2021 Research Grant guideline is created to support the 2021 Research Grant program's implementation, which contains detailed information regarding the preparation, implementation, and reporting of the 2021 Research Grant Program.

#### C. PURPOSE AND OBJECTIVES

- a) To increase research quality which supported the vision and mission of SEMAEO to be regional research, advocacy, and capacity building center of excellence on ECCE and Parenting in the national level and Southeast Asia region.
- b) To raise the current issues related to Early Childhood Education and Parenting through various research themes.
- c) To develop collaboration with an organization and educational institution at the national level to cooperate and collaborate in the research and technology transfer.
- d) To increase international recognition through research dissemination and international journal publication.

#### D. ELIGIBILITY

The research grant is open to lecturers, researchers, academics, ECE education practitioners (including headmaster or teacher) from Southeast Asia countries. In 2021, the total of the grant is 14 grantees.

#### E. RESEARCH THEMES

Research studies may cover one or more areas in supporting SEAMEO CECCEP programs, as follows:

#### a) Quality Learning Environment

The quality of the ECE learning environment should be seen as a complex and dynamic system. Further, this theme includes the quality of teachers, facilities and infrastructures, teacher-child and teacher relationships, children's experiences with peers, children's and teacher's perspectives on their learning environment, and teaching-learning experience in the home environment.

#### b) Policy and Programs for 21st Century Learning

This theme includes reviewing early childhood education policies and programs, analyzing and comparing ECE policies in Southeast Asia, or developing curriculum programs for learning in the 21<sup>st</sup> century.

#### c) Inclusive Family Education Program

The theme is to explore the best parenting practices from disadvantaged backgrounds such as low socio-economic-status families, minority groups, indigenous communities, certain ethnicity/cultures, or families with special needs children..

#### d) The 21st Century Parenting

This theme covers the parents' parenting challenges in the 21st century, such as technology, changes in family structure, single-parent families, multicultural family background (ex: families with different nationalities), and father and mother's role division.

#### e) Assessment for children development

The theme focuses on developing assessment tools to screening and measuring the aspects of early childhood development aged 0-2 years and 2-4 years. The objective of the assessment is to screen the child's developmental stages and tasks. This instrument tool is targeted to be applied in Southeast Asian countries. In the research process on developing the instrument, various contexts should be considered, including the linguistic, cultural, and social backgrounds.

#### f) Study on Strategic Issues and Challenges on ECCE and Parenting

This theme covers the global latest issues the ECE and Parenting, such as emergency response in the ECE, Covid-19 pandemic, disasters, or others.

#### g) Innovative Financing for ECCE

This theme focuses on research to recommend the right, innovative, and sustainable financing model for the ECE center.

#### h) Strategy on ECCE Advocacy and Assistance

This theme focuses on research to find a good model of advocacy and assistance in the ECE and Parenting in a school and community.

#### II. GRANT TERM AND CONDITION

#### A. SEAMEO CECCEP Research Grant 2021 Program

The SEAMEO CECCEP Research Grant 2021 Program is a research grant program from SEAMEO CECCEP for lecturers, researchers, academics, or educational practitioners chosen through a selection process and proposal approval. The program objective is to stimulate the researcher to enrich knowledge and develop ECE services and Parenting.

The program objective is in line with the vision and mission of SEAMEO CECCEP to become a regional center of excellence for research, advocacy, and capacity building in ECD and Parenting at the national and regional Southeast Asia levels.

#### **B.** Applicant Criteria

- a) Proposal is made according to research ethic.
- b) Proposals will be selected administratively. Proposals that do not meet the administrative requirements will be rejected and not forwarded to the substantive selection.
- c) Applicants can be in the form of individuals or teams.
- d) The maximum number of the research team is four, including the lead researcher.
- e) Applicants are eligible to submit one research proposal.
- f) Applicants are not allowed to receive funding from other parties to fund the proposed research.
- g) The lead researcher had never received research funding from SEAMEO CECCEP in the previous year.
- h) Applicants who are non-Indonesian citizens (WNA) must have one of the team members who is an Indonesian citizen (WNI).

#### C. Application and Implementation Process

#### a) Publication

The program begins with the announcement on the SEAMEO CECCEP website and its media social. The announcement is followed by a research grant guideline that can be accessed at the SEAMEO CECCEP website.

#### b) Application

Research applications are carried out by lecturers, researchers, academics, or educational practitioner by accessing the SEAMEO CECCEP website, and the application stages are as follows:

- Applicants for research grant access the online application through the SEAMEO CECCCEP website.
- 2. Applicants are advice to download the research grant guideline.

- Applicants should follow the guideline to complete the research proposal and administrative documents.
- 4. Applicant should create an account and upload the research proposals on the official SEAMEO CECCEP website.

#### c) Selection/Nomination

The selection process is assessed through a competitive review by the committee and reviewer, which the director of SEAMEO CECCEP has arranged. The selection process for research grants is consists of the following stages:

- 1. The committee and reviewer screen all applications received to ensure that applications are complete administratively and substantively, including the budgeting plan to assess whether the proposal is eligible to be included in the selection process.
- 2. The committee and reviewer issue a recommendation on selected research proposal to the Director of SEAMEO CECCEP;
- According to the recommendation from the committee and reviewer, the Director of SEAMEO CECCEP as the person in charge of the program, will issue a decision letter on the determination of the SEAMEO CECCEP Research Grant Research 2021;

The nomination process is to nominate a research team through the assignment procedure. The assignment procedure intended for research is considered strategic according to the competence of the institute and the research team with the following conditions:

- 1. The research team is assigned to conduct research based on assignment and agreement from SEAMEO CECCEP
- 2. The research team submit the research proposal to the committee through the official website SEAMEO CECCEP
- 3. The committee and reviewer still assess the research proposal submitted by the assignment team.

#### d) Announcement

The determination of research proposals funded by the SEAMEO CECCEP Research Grant is regulated with the following conditions:

- 1. The committee and reviewer issue a recommendation on eligible research proposal to the Director of SEAMEO CECCEP;
- According to the recommendation from the committee and reviewer, the Director of SEAMEO
  CECCEP as the person in charge of the program, will issue a decision letter on the
  determination of the SEAMEO CECCEP Research Grant Research 2021;
- Announcement of proposal approval will be published on the official website of SEAMEO CECCEP.

#### e) Implementation

The implementation of the *Research Grant SEAMEO CECCEP* 2021 is regulated with the following conditions:

- 1. Successful applicants are required to sign grant agreements with SEAMEO CECCEP.
- 2. The grant agreement is signed immediately after the announcement of the proposal acceptance.
- 3. The grant agreement contains:
  - 1) The official signed
  - 2) Term and condition of the grant
  - 3) The total of fund received
  - 4) The term of the contract
  - 5) Target Output
  - 6) Rights and obligations
  - 7) Reporting
  - 8) Monitoring and evaluation
  - 9) Changes in the research team and research substance
  - 10) Taxation
  - 11) Intellectual Property
  - 12) Force majeure
  - 13) Sanction/Penalty
  - 14) Dispute/Legal Action
- 4. The researchers are required to conduct the research with the following conditions:
  - 1) Researcher should implement the research activities following the proposed research schedule.
  - 2) Researcher should be documenting the research process on the research logbook. The logbook consists of documentation of research progress, including detailed information of the research process, research materials, research method, data collection, data analysis, and additional information. The research logbook must be submitted on the

- SEAMEO CECCEP website Research Grant. The logbook will be assessed as a supporting research document.
- 3) Researcher are obligate to documented the research progress.
- 4) Researcher writes and submits the research report through the SEAMEO CECCEP website Research Grant.
- 5) Supervision and monitoring of research implementation will be done by the monitoring and evaluation team designated by the Director of SEAMEO CECCEP
- 6) The results of Monitoring and Evaluation are reported to the Director of SEAMEO CECCEP

#### f) Reporting

Researchers are obliged to provide progress reports, year-end reports, and final reports with the following conditions:

- 1. The lead researcher is required to report the receipt of funds to the Director of SEAMEO CECCEP in the written report or through electronic media (telephone, email, fax) no later than two weeks after the funds are received.
- The lead researcher shall report the daily research activity records according to the specified deadline on the research schedule. The report must be submitted through the SEAMEO CECCEP website (format attached).
- 3. The lead researcher shall submit the research progress report according to the specified deadline on the research schedule. The report must be submitted through the SEAMEO CECCEP website (format attached).
- 4. The lead researcher shall submit the final report according to the specified deadline on the research schedule. The report must be submitted through the SEAMEO CECCEP website (format attached).
- 5. The lead researcher shall writes Statement of Asset Handover (*Surat Pernyataan Berita Acara Serah Terima Aset*) (format attached).
- 6. SEAMEO CECCEP will register/publish the Intellectual Property of the research output (Models, Teaching Materials, Modules, Policy Briefs, Books, Products, etc.)
- 7. The lead researcher is obliged to make an English-language research journal of the research results. This article will be published in the SEAMEO CECCEP journal.
- 8. The lead researcher must write and submits financial reports to the SEAMEO CECCEP Research Grant committee.
- 9. All research grant recipients are required to disseminate their research results in the "Dissemination of Research Results of the SEAMEO CECCEP Research Grants". In this activity, SEAMEO CECCEP only covers costs during the activity, while the transportation costs are included in the research grant.

#### g) Assessment of Research Results

The stages of assessing research results are follows:

- 1. Researcher is obligated to report the research progress, final research result, and other research outcomes as promised to SEAMEO CECCEP.
- 2. The external assessor and/or reviewer conduct the assessment process to assess the feasibility of research implementation regarding the submitted report and other research outcomes.
- 3. The external assessor and/or reviewer provides recommendations to the SEAMEO CECCEP of the assessment results consisting of:
  - 1) The percentage of research success rate following the promised recommendations;
  - 2) Suggestions and inputs related to the suitability of the fund aid that has been given to the research results;
  - 3) Suggestions and inputs related to research sustainability;
  - 4) The assessment of the fulfillment of the scientific ethic and principles of research; and
  - 5) The results of the assessment and recommendations are written in the submitted report to SEAMEO CECCEP.

#### h) Reviewer

Reviewer are obligated to conduct research assessment in accordance with the regulations determined. Reviewer shall meet the following requirements:

- 1. Have a responsibility, integrity, honesty, following code of ethics, and able to carry out duties as an assessor and/or reviewer;
- 2. Doctoral education with a functional position (min. Lector); or magister with a functional position head Lector;
- 3. Experienced in Community Service, had been chief executive at least once in multi-year activities and once in mono-year activities;
- 4. Experienced in scientific publications in accredited international and / or national journals as the main author (first author) or correspondence author;
- 5. Experienced as a speaker in international and/or national scientific seminars; and
- 6. Preferably have h-index from reputable international indexing institutions, experience in teaching materials and holding Intellectual property right.

#### D. Research Funding

In the total, there will be 14 selected proposals that received grants from SEAMEO CECCEP through competitive selection. The successful applicant will get IDR 25.000.000 - 50.000.000 for conducting the research within 6 months.

#### a) Budgeting Plan

All the funding should be used for the research activities, as follows:

- 1. Honorarium (Resource Person)
- 2. Research Material (Stationary, Administration, Documentation, Photocopy, and Reporting)
- 3. Operational material (Accommodation, Transportation, Meal)
- 4. Non-operational material (Dissemination/Publication/Intellectual Property Rights)

#### b) Funding Administration

Researchers are required to manage aid funds with the following conditions:

- 1. Using aid funds by referring to the terms and conditions contained in the Agreement Letter and the guidelines established by SEAMEO CECCEP.
- 2. Administer all expenditure accompanied by receipt / valid proof of expenditure (in accordance with the regulations on the use of state funds). All evidence of expenditure is made in 2 (two) copies. The first copy is for researcher archives and the second copy is attached on the research report submitted to the Director of SEAMEO CECCEP.
- 3. Researchers who do not report physical evidence of the use of funds and tax payments are categorized to have not used the funds and have not accounted for their finances.
- 4. Documenting and administering all financial expenditures in a responsible manner for the preparation of audits by auditors (Inspectorate General of the Ministry of Education and Culture, the Audit Board of Finance and Development (BPKP), the Supreme Audit Agency (BPK), Bawasda/Bawaska or other business parties) and stored for a 5 (five) years in minimum period.

#### c) Use of Funding

- 1. Payment of honorarium. Each payment of honorarium must have proof of receipt from the recipient (may not be represented).
- 2. Purchase of goods. Every purchase should be proven by an official receipt from the company/store, complete with the seller's signature with the stamp from the company/store.

3. Purchase for consumption/meal. Purchase of consumption/meal should be made through a caterer or a restaurant. Every purchase should be proven by an official receipt from the caterer/restaurant, complete with the seller's signature with the stamp from the caterer/restaurant.

#### d) Taxation

Grantees are responsible for making their own arrangements regarding any taxation liabilities that may arise from the award of funding. Grantees are also responsible for the following actions:

- 1. Request proof of purchase tax payment for every purchase made;
- 2. Withholding the honorarium regarding the PPh pasal 21 and depositing the proceeds of tax collection to the State Treasury following tax provisions or regulations;
- 3. Documented all tax payment proofs;
- 4. Attach a copy of all proof of tax payment in the final report.

#### E. Research Implementation Schedule

The research implementation schedule is prepared based on a predetermined time by considering the availability of funding and each stage's achievement. Determination of the research implementation schedule and report submission is as follows:
